# Event 2 of the Quebec Circuit **NOTICE OF RACE**

July 8 to 10 2022

Pointe-Claire Yacht Club, Pointe-Claire, Québec Organizing Authority: Pointe-Claire Yacht Club (PCYC)

#### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing.
- 1.2. If there is a conflict between languages, French will take precedence.
- 1.3 The Organizing Authority is Pointe-Claire Yacht Club, 1 Cartier Avene, 514-695-2441.
- 1.4 Sailors and their parents or guardians are responsible for deciding whether to participate or not, and for compliance with all COVID-19 regulations and guidelines.

#### 2. ELIGIBILITY AND ENTRY

- 2.1. The regatta event will be limited to the following classes of boats: Optimists, Optimist Green, ILCA 4 (Laser 4.7), ILCA 6 (Laser Radial), and Club 420. It's possible to accept other classes; a different scoring may be used.
- 2.2 Competitors in the ILCA classes may choose Radial or 4.7 rigs at their discretion for the duration of the event.
- 2.3 A minimum of 5 registrations made at least one week before the event is required to constitute a class.
- All competitors must sign the liability form (page 6). If the athlete is under 18 years of age, the form must be signed by the legal guardian and emailed to <a href="mailto:pcycoffice@pcyc.qc.ca">pcycoffice@pcyc.qc.ca</a> or faxed to 514 695-2341. All competitors must be members in good standing with the FVQ / Sail Canada and provide proof of age.
- 2.5 Registration will be completed when all the necessary documents and full payment has been submitted.
- 2.6 All athletes must have been born in 2003 or after.

#### 3. FEES

3.1 Fees for the Regatta including taxes. These fees include Saturday dinner.

- 3.3 Registration forms are available on the FVQ's website: www.voile.qc.ca. After July 7<sup>th</sup>, 12PM. registration will be on-site between 9AM and 10AM July 8th. Additional fees will apply for registrations done after July 1<sup>st</sup> and for on-site registration.
- 3.4 For registration on site, cheques should be payable to Pointe-Claire Yacht Club, or e-transferred to <a href="mailto:accounting@pcyc.qc.ca">accounting@pcyc.qc.ca</a> and put the entries first and last name in the memo section of the email.
- 3.5 There is no fee for a support boat with or without a coach, but support boats must be registered at the club office.

4.2. No warning signal will be given after 15h00 on the last day of the regatta.

## 5. SAILING INSTRUCTIONS

Sailing instructions will be available at the club's Notice Board on the veranda and on the PCYC and FVQ's websites.

#### 6. COMMUNICATION

## 7. COURSES

The courses to be sailed will be windward-leeward races.

#### 8. SCORING

- 8.1. Seven races for each class are planned during this regatta but there may be more or less.
- 8.2. One race is required to be completed to constitute a series.
- 8.3. When fewer than five races have been completed, a boat's series score will be the total of the race scores.
- 8.4. When five or more races have been completed, a boat's series score will be the total of the race scores excluding her worst score.
- 8.5. The scoring for all qualifying events will be counted to determine overall results for the Circuit du Quebec.

# 9. SUPPORT BOATS

- 9.1. Support boats are not permitted near competitors during races except for Green Fleet Coaches.
- 9.2. Support boats will be identified by the boats or coachs name.

#### 10. BERTHING

- 10.1. Boats must be kept in their assigned areas in the boat park.
- 10.2. Trailers must be stored in the area assigned by the club.
- 10.3. Support boats must dock where asked.

#### 11. PRIZES

Prizes will be awarded to the top 3 finishers of each class except Opti-Green Fleet.

## 12. DISCLAIMER OF LIABILITY

- 12.1. Competitors participate in the regatta entirely at their own risk. See Racing Rules of Sailing RRS 3, Decision to Race. The organizers and Pointe-Claire Yacht Club will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta. The organizers encompass everyone helping to run the event.
- 12.2. By registering, the participant to this regatta gives authorization and cedes rights for the use and reproduction of pictures and videos, of himself and of his boat during the sailing event, in the prospect of being published in any type of Web media, newspapers, or advertisement.

#### 13. INSURANCE

Each participating boat shall be insured with valid third-part liability insurance with a minimum cover of \$500,000.00 per incident or the equivalent. The organization assumes no responsibility in the verification of insurance.

#### 14. FURTHER INFORMATION

Camping is not available on-site.
